1. **INTRODUCTION**

Autovert Technologies Private Limited (hereinafter referred to as “**Autovert**”, “**We**”, “**Us**”, “**Our**”, “**Data Fiduciary**”, “**Data Controller**”) is a company with CIN: U74999KA2017PTC102090, incorporated under Companies Act, 2013 and is governed by the Digital Personal Data Protection Act, 2023, (“**DPDP**”) providing battery for sale/lease to buyers of various electric vehicles (Two-wheelers ,Three-wheelers & Four-wheelers) and for Solar Rooftop Installations.

2. **PURPOSE**

The following Data Privacy Policy (hereinafter referred to as “**Privacy Policy**”, “**Privacy Notice**”, “**Privacy Statement**” or “**Policy**”) aims to describes how We collect, use, and disclose information and what choices that the person (hereinafter referred to as “**User**”, “**Data Principal**”, “**You**”, “**Your**”) using the website or Our m-site (hereinafter referred to as “**Platform**”) have with respect to the information. Through this Privacy Policy We aim to provide a synopsis of our privacy practices regarding the personal information that We collect and process from You through various sources. We understand that the importance of data protection increases as the amount of data created and stored in the course of business operations, continues to grow at unprecedented rates. We firmly believe that data protection is the cornerstone of building trustworthy business relationships and thus We aims to safeguard all data We collect from potential compromise, ensuring its privacy, confidentiality, and availability. Autovert is the controller for the personal data discussed in this Privacy Statement, except as noted in Para 14(b).

3. **SCOPE**

This Privacy Policy applies to all Our employees, prospective employees, customers, Users and Platform visitors. This Privacy Notice also applies to Our prospective customers who visit the Platform to understand the services provided by Us.

For the purposes of this Notice “**Personal Data**” or “**Data**” shall mean all the personal and identifiable information collected of an individual.

Autovert is responsible for safeguarding the privacy of the data provided by users through its own channels. However, Third-Party Service Providers that Autovert may engage with, are responsible for collecting data from various sources, including Autovert's channels, and Autovert shall not be responsible for the same.

4. DATA PROTECTION PRINCIPLES

The following key principles are enshrined in the Applicable Laws and are fundamental to Autovert’s Privacy Policy. In its capacity as a Data Controller, Autovert ensures that all its activities shall abide by the following principles:

- a. Processing shall be performed lawfully, fairly and in a transparent manner.
- b. Personal Data shall be collected for specified and explicit purposes and not further processed in a manner that is incompatible with those purposes; further processing for any other purposes is permissible if they are similar or relevant to the purposes for which such data was originally collected.

- d. Personal Data shall be accurate and, where necessary, kept up to date;
- e. Personal Data shall be kept in a manner that ensures appropriate security of the Personal Data, including protection against any infringement, breach or unauthorised or unlawful processing, using appropriate technical or organisational measures by complying with the Applicable Laws in this regard;
- f. Personal Data shall not be kept after the completion of the purpose for which such data is processed, provided that such data may be further kept if its Data Subject can no longer be identifiable using the “anonymization” technique, or if required as per Autovert’s policy or as per Applicable Laws.

- 5.8** To effectuate a financial transaction, we may disseminate financial information provided by you (such as payment mode particulars) to authorized third parties, for instance, our business associates, financial institutions, or government authorities involved in the fulfilment of the said transactions.

7. CONSENT

- 9.3** We shall exclusively employ Your Personal Data for the designated intentions for which it was acquired unless if we reasonably determine that there exists a need to employ it for an alternative rationale that aligns with the original purpose, for which your data was collected, in such an event We shall duly inform You and elucidate the legal foundation that permits Us to proceed accordingly and we shall proceed only after you have consented for the same.
- 9.4** Except where specifically agreed or necessary for operational or regulatory reasons, We will not send You any unsolicited information. However, to help the User take full advantage of the service offerings of Autovert, You will have the opportunity to indicate whether You would like to "opt-out" of receiving promotional and/or marketing information about other products, services and offerings from Ours and/or any third parties' end. - 9.7** We use your Personal Data to display interest-based advertisements for features, products, and services that might be of interest to you. We do not use Data that personally identifies you to display interest-based advertisements.
- 9.8** We use Personal Data to prevent and detect the possibility of non-payment, fraud, and abuse in order to protect the security of our Users, the Company, and others. We may also, directly or through a third-party (including Credit Information Companies (CIC)), use scoring methods to assess and manage credit risks, including by way of sharing the result of said scoring methods with relevant third-parties, payment gateways and financial institutions.
- 9.9** We may use your Data to generate and review reports and data, and to conduct research on the Company's user base and service usage patterns and to conduct research following internal review protocols to ensure the balancing of privacy and to use anonymized data for research.
- 9.10** We may use your Data to carry out our obligations and for enforcing rights arising from any contracts entered into between you and the Company, including for billing and collection purposes.

10. LEGAL BASIS FOR PROCESSING YOUR PERSONAL DATA

We process Personal Data based on one or more of the following processing conditions:

10.1 Contractual Necessity: Personal Data may be processed when it is essential for the performance of a contract to which You are a party or in order to take steps at Your request prior to entering into a contract e.g. when You would engage with Us for receiving Our services and offerings.

10.2 Legitimate Interest of the Business: Data processing may occur when it serves the legitimate interests of Autovert, provided that such interests do not override the rights and freedoms of the Data Principals.

10.3 Vital Interest of Data Subject: In situations where it is crucial to protect the vital interests of the Data Subject, Personal Data may be processed.

10.4 Legal Obligation: Personal Data may be processed to comply with legal obligations to which Autovert is subject, including Applicable Laws and for protecting Our legal rights, seeking remedies and defending against any adverse claims made.

11. RIGHTS OF DATA PRINCIPAL

12. RESPONSIBILITIES OF DATA PRINCIPAL

Data Principals have certain responsibilities to aid Data Fiduciaries to carry out their duties in accordance with Applicable laws. These are:-

13. DATA STORAGE AND RETENTION

We maintain reasonable administrative, technical, and physical safeguards to protect Personal Data against accidental or unlawful destruction, loss, alteration, unauthorized disclosure, or access. We retain Personal Data for as long as necessary for the purposes for which it was collected or as per the Applicable Laws. Personal data that is no longer required to be retained as per legal and business requirements will be disposed in a secure manner. The Data collected through this process shall be stored in such jurisdiction and geographies as permissible under the Applicable Law.

14. SHARING PERSONAL INFORMATION OF USER/S

- (a) We may share Your Personal Data with our service providers, post acquiring Your specific consent e.g. Our third-party lenders, etc or Your generic aggregated demographic information, not linked to any personal identifiable information regarding User/s with Our subsidiaries, Our business partners, trusted affiliates, and advertisers for the purpose of providing You with the relevant services and personalised experience. We may further do so if We are required by a court order, government authorities, law enforcement authorities, credit information companies or by any other statutory body as per Applicable Law or where it becomes necessary to do so to protect Our rights or property in order to establish, exercise or defend its legal rights.

When such a Third-Party Service Provider collects your Data directly from you, you will be governed by their privacy policies. We use the help of Internet Protocol ("IP") addresses to diagnose any problems with its server and to administer our website including blocking certain addresses that it feels are inappropriately using our Platform. IP addresses are used to gather broad demographic information, such as browser types, Visitor's country, visiting frequency, operating systems, etc.

By using Our website (ecozaar.in), or m-site (hereinafter referred to as "**Platform**") and selecting the appropriate preferences, you consent to Our use of cookies, IP addresses and Our use of other methods to collect Platform usage data as detailed in this cookie policy (hereinafter referred to as "**Cookie Policy**"). Please read this Cookie Policy together with the privacy policy posted on Our Platform.

This Cookie Policy explains how Autovert uses cookies and similar tracking technologies when you use Our Platform and services. By using Our Platform and services, you consent to the use of cookies and tracking technologies as described in this Policy.
